Privacy Policy

This Privacy Policy governs the manner in which the Network of Organizations for Science and Technology Communication (NOSTC) collects, uses, maintains, and discloses information collected from users (each, a "User") of the https://sjc.nostc.in website ("Site"). This privacy policy applies to the Site and all services offered by SJC NOSTC.

Personal identification information

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our site, register on the site, subscribe to the newsletter, fill out a form, and in connection with other activities, services, features or resources we make available on our Site. Users may be asked for, as appropriate, their name, email address, and mailing address. We will collect only personal identification information from Users if they voluntarily submit it to us. Terms

- 1. The course spans a period of 6-weeks, and participants are expected to attend all classes according to the schedule, which will be periodically shared or published on the website or communicated through various channels such as messages, calls, or emails.
- Attendance Maintaining a sufficient level of attendance is crucial in order to successfully complete a course. To be eligible for a Course Completion Certificate, it is mandatory to maintain a minimum attendance of 75%. If a student fails to meet this requirement, they will not receive a Course Completion Certificate. Instead, they may be provided with a Certificate of Participation.
- 3. Assessment To fulfill the criteria for obtaining a course completion certificate, students must fulfill additional prerequisites, such as fulfilling assessment requirements through assignments (individual or group), tests, reports, or similar tasks. It is essential for participants to submit their assignments by the designated deadline. Late submissions or any other justifications will not be accepted.
- 4. Mode The course will mainly be offered in a hybrid or virtual format. Students must participate in the sessions by accessing the provided joining links either on the website portal.
- 5. Fee Participants who fulfill all the requirements for a certificate of completion will be eligible for a refund of the fee. However, if the attendance criterion is not met or the assessment is not submitted, the refund option will be forfeited, and only a certificate of participation will be awarded at the end of the course, following the guidelines set by NOSTC officials.
- 6. TA It is important to note that no Travel Allowance (TA) or Daily Allowance (DA) will be granted. The focus is to ensure that the student has a place to stay during their time at the university, but financial support for travel expenses or daily expenses is not included. The student is responsible for covering their own travel and daily expenses except the hostel and mess facility, which might be provided by the university.
- 7. Residential Facilities Accommodation, if provided or availed, will adhere to the statutory guidelines of the university. The facilities not provided by the university cannot be claimed as entitlements while staying in the accommodation provided or availed within or outside the university campus.
- 8. Mess The food will be vegetarian, provided in the hostel mess during the mess timings. One accountable for any change will be liable to pay charges.
- 9. Laundry Please note that laundry facilities may be available for individuals residing in hostels, but charges will apply. Additionally, the timing for laundry services will be according to the hostel guidelines, the clothes may not be returned the same day and any damage to the participant's property will not be under the university's responsibility.
- 10. Campus Guidelines During their stay on the university campus, participants are expected to adhere to the guidelines, rules, and regulations set by the university. This includes abiding by designated

hostel timings, refraining from taking leave, and not being permitted to leave the campus premises while residing in the hostels.

- 11. Government Guidelines The participants are also required to follow any guidelines issued by the Government for the university till their stay on campus.
- 12. Please note that we maintain the authority to make alterations to this privacy policy at any given time, thus we advise you to regularly review it. Any amendments or clarifications will become effective immediately once they are published on the website.
